



Activity Consent Form – Year 2 Drama Lessons

1 February 2021

Dear Parent/Carer

On Monday, 8 February 2021 we will be commencing drama lessons as part of our Semester 1 Drama Unit.

The aim of the activity is for students to learn how to describe what happens in the drama they make, perform and view, which will compliment activities completed in the classroom. Each student will be assessed on the drama component of the Arts curriculum.

Activity details:

Classes will commence, during school time, on **Monday, 8 February 2021** (Term 1, Week 3) and continue on a weekly basis for 8 weeks in all. Each lesson will be held in the Kurwongbah State School hall for 40 minutes per week.

Creative Dance Industries provides professional drama teachers who are well equipped to teach the students skills that will help in many areas of their life. Class teachers will also be supervising lessons.

Students will:

- Explore role and dramatic action in dramatic play, improvisation and process drama.
- Present drama that communicates ideas, including stories from their community, to an audience.
- Respond to drama and consider where and why people make drama, starting with Australian drama including drama of Aboriginal and Torres Strait Islander Peoples.
- Use voice, facial expression, movement and space to imagine and establish role and situation.

Students should wear their school uniform and suitable shoes for drama lessons.

Activity costs: \$12.00 in total per child for 8 lessons.

Kurwongbah State School is a cashless school. Preferred payment method is BPOINT (using the BPOINT link on the invoice emailed to you). Payment can also be made by QParents, EFTPOS or Cheque/Money Order (payable to Kurwongbah State School). **Payment must be made by Friday, 19 February 2021. No late payments can be accepted. Please return permission form to the office by Friday, 5 February 2021.**

Refund Guidelines for Activities:

At Kurwongbah State School we are committed to providing a safe and supportive learning environment for students, staff and volunteers. This commitment includes the health and safety of staff and students when conducting curriculum activities in the school or in other locations.

School excursions and camps enhance a student's learning by providing opportunities for the student to participate in activities, both curriculum-related and recreational, outside the normal school routine. All planned school excursions are approved by the Principal and endorsed by the Parents and Citizens Association.

State schools are able to charge a fee for:

- An educational service including materials and consumables not defined as instruction, administration and facilities for the education of the student;
- An education service purchased from a provider other than the school where the provider charges the school; and
- A specialised educational program.

A school fee is directed to the purpose for which it is charged.

School fees for excursions and camps are calculated on a cost recovery only basis, according to the number of students who have indicated their attendance.

Participation of students in an excursion or camp is indicated through payment of the excursion or camp fee and provision of a permission form completed by the parent/carers.

As the school budget cannot meet any shortfalls in funding for an excursion or camp due to the subsequent non-participation of a student who had previously indicated attendance of the activity, fees already paid for an excursion or school camp may be refunded in full or in part or not at all, having regard to the associated expenses incurred and the circumstances of the non-participation.

If a parent/carer wishes to apply for a refund due to their child's non-participation in an excursion or camp activity, they may do so by completing a Request for Refund form available from the school office. Where possible, the request should include the receipt relating to the payment for which a refund is being sought.

Privacy notice

Please take this into consideration in deciding whether or not to allow your child to participate in this activity.

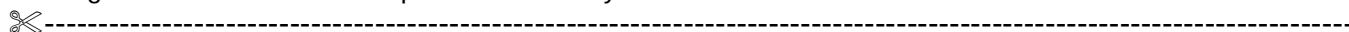
