Activity Consent Form - Year 5 Eureka Gold Rush Excursion

1 June 2022

Dear Parent/Carer

On **Monday 25 July (Term 3 Week 3),** Year 5 will be attending the Eureka Gold Rush Excursion as part of our term three work in HASS.

Activity Details:

The Eureka Gold Rush Excursion is a full day, interactive learning experience. It has been described as 'A great, real life authentic learning experience'. Students will learn about the population explosion, immigration, cultural differences, democracy and unions. They will learn about health and diseases on the gold fields, the Chinese prospectors, claims and claim jumping, 'candlelighters' tent robbers etc, characters, occupations, tools and equipment and gold licences. Students will also be involved in role-plays, tent making and mapping activities combined to engross students in the life of a simulated New South Wales gold field township in 1854.

On the day, students will need to be at school at **7:00am** ready to depart by bus to Belivah - a suburb of Logan City by **7:15am**. The days activities will run from 9:00am to 2:30pm. The bus should return to school by about **4:00pm**.

For the excursion your child should have a water bottle, morning tea and lunch. There is no tuckshop available at the excursion site. They will also need a hat, sunscreen, and fully enclosed shoes suitable for bush walking. They will require insect repellent as mosquitos and ticks may be present. A raincoat/jumper/jacket should be packed as the excursion will continue to run in light rain. Please ensure your child is prepared for a day outdoors. For asthma suffers, during periods of dry weather the site can get dusty. Students are also asked to bring a 20 cent coin, which children must carry themselves, as it is vital in emphasising logical consequences throughout the day. They use it to buy their gold licence which they must have, to search for gold at the end of the day. If they forget or lose it they must find a way in keeping with the 1850s era to acquire a licence.

To maximise the enjoyment of the day, it is recommended that children and adults dress in appropriate costume for life on the goldfields in the 1850s. When choosing a costume please prioritise comfort - clothing should be suitable for an active day outside. Don't stress, as it is all for fun. Definitely **no hire costumes** as children often get quite dirty on the day.

Some character suggestions include: Teacher, Baker, Trap (Constable, Sergeant, etc.), Governor, Store Keeper, Blacksmith, Entertainer, Coach driver, Squatter/Wife, Prospector or Digger (Australian, Chinese, Irish etc.), Assayer, Banker, Claims Officer, Government Official (Clerk), Tent Maker, Barber, Sly Grog Shop Owner (Barman), Drifter (Swagman), Escaped Convict, Tobacconist, Newspaper Editor. * **Note – No Bushranger.** They already have one of them.

Activity Costs: \$39.00 per student

The cost of the excursion is **\$39.00**. For students to participate on the day they must have filled out the attached forms:

Kurwongbah State School is a cashless school. Preferred payment method is BPOINT (using the BPOINT link on the invoice emailed to you). Refund Guidelines for Activities:

At Kurwongbah State School we are committed to providing a safe and supportive learning environment for students, staff and volunteers. This commitment includes the health and safety of staff and students when conducting curriculum activities in the school or in other locations.

School excursions and camps enhance a student's learning by providing opportunities for the student to participate in activities, both curriculum-related and recreational, outside the normal school routine. All planned school excursions are approved by the Principal and endorsed by the Parents and Citizens Association.

State schools are able to charge a fee for:

- An educational service including materials and consumables not defined as instruction, administration and facilities for the education of the student;
- An education service purchased from a provider other than the school where the provider charges the school;
 and
- A specialised educational program.

A school fee is directed to the purpose for which it is charged.

School fees for excursions and camps are calculated on a cost recovery only basis, according to the number of students who have indicated their attendance.

Participation of students in an excursion or camp is indicated through payment of the excursion or camp fee and provision of a permission form completed by the parent/carer.

As the school budget cannot meet any shortfalls in funding for an excursion or camp due to the subsequent non-participation of a student who had previously indicated attendance of the activity, fees already paid for an excursion or school camp may be refunded in full or in part or not at all, having regard to the associated expenses incurred and the circumstances of the non-participation.

If a parent/carer wishes to apply for a refund due to their child's non-participation in an excursion or camp activity, they may do so by completing a Request for Refund form available from the school office. Where possible, the request should include the receipt relating to the payment for which a refund is being sought.
